President Azure Holland, DVM reviewed for the Board the Governor's and the North Carolina Ethics Commission's statements on recognizing and avoiding conflicts of interest. She also reviewed N.C.G.S. § 90-179 of the North Carolina Veterinary Practice Act.

The September 11, 2025, Board meeting minutes were reviewed and approved. Ronald Komich, DVM made a motion to accept the minutes and Andrea Genryt- Apple, DVM seconded the motion. The motion passed unanimously.

**North Carolina Professional Health Program (NCPHP) Report:**

Joseph P. Jordan, PhD, Chief Executive Officer, presented his report on the status of the program attendance, provided updates and discussed resources available from the program for veterinarians and veterinary technicians regarding their mental health and overall health.

**State Veterinarian's Report:**

Michael Martin, DVM provided an update on the status of highly pathogenic avian influenza (HPAI), and New World screwworm cases and case numbers.

**Legislative Committee Update:**

Executive Director, Keith West stated that feedback was received from interested parties regarding the proposed legislation and that he is currently reviewing the information. He also stated that he will provide another update on the proposed language for legislation introduction at the next meeting after the Legislative Committee meets in December.

**Facility Inspection Report:**

Executive Director, Keith West provided a report on all of the inspections since the last meeting totaling 191 inspections with no serious violations. Robert Bakal, DVM completed 73 inspections, Marjorie McFetridge, DVM completed 36 inspections, Nicolette Peer, DVM completed 61 inspections, Andrew Horne, DVM completed 19 inspections, and Marisol Iannuzzi, DVM completed 2 inspections.

Mr. West stated that inspections are moving along well and inspectors are receiving good feedback.

Mr. West also reported that there are only approximately 10 facilities left that have not submitted their facility permit application. Staff continues to work to bring all facilities into compliance.

**Rules Update Report:**

Deputy Director, Melissa Bowman stated that the review and update of the administrative rules for the periodic review process with rules continues. The board has 47 rules that must be readopted by December 2027, with 12 rules completed, 10 ready for pre-review, and 10 in-progress. Updated rules will be brought to the Board for consideration over the next year.

**Attorney's Report:**

Board Attorney, Matthew Skidmore stated that 22 closing letters have been mailed since the last meeting and a total of 12 closing letters are expected to be completed this month. Mr. Skidmore stated Susan Bull, DVM's role as the Board's complaint investigator, has helped with the complaint volume increase with 27 complaints being dismissed at the Executive Director level after a thorough investigation before a referral to the Committee on Investigations.

**Student Liaison's Report:**

Secondary Student Liaison, Sydney MacDonald read Primary Student Liaison, Bec Mitchell's report which included a review of the AAVSB 2025 conference, with mentions of Michael Martin, DVM's report and congratulated Robin Lazaro, RVT's on her new position. Ms. Mitchell is thankful for the opportunity to attend the conference. Ms. Mitchell provided in her report the upcoming activities at NCSU CVM, and their plans to revive their NCVMB newsletter.

**Executive Director's Report:**

Executive Director, Keith West reported that the Board's finances remain in good standing. Mr. West presented the status report of the number of active Veterinarians and Registered Veterinary Technicians and stated that the number of applications still continue to increase.

Mr. West reported that the Board's draft audit was received with no issues and that he will provide a copy of the final draft to Board members in January once it is available.

Mr. West took a moment to acknowledge all Board staff members on the amazing job they have done this past year with all the changes that took place. He also complemented their work, work ethic and stated that they are an excellent, trustworthy group of staff.
