AMENDING OR DISSOLVING A PROFESSIONAL CORPORATION OR PROFESSIONAL LIMITED LIABILITY COMPANY

A copy of the Articles of Amendment or Articles of Dissolution must have prior Board approval before being executed by the Secretary of State's office. Enclosed is that application. Submit this application with a copy of the Articles of Amendment or Articles of Dissolution. An approval certificate will be returned to you, which must accompany the Article of Amendment or Articles of Dissolution to the Secretary of State's office.

Professional corporations and/or professional limited liability companies are subject to the requirements of the Rules and Regulations of the Veterinary Medical Board and the provisions of Chapter 90 and 55B of the North Carolina General Statutes.

Note that failure to comply with any requirements of the North Carolina Veterinary Medical Board could result in suspension of the corporation. The Secretary of State's office will suspend the corporation for violations on behalf the NCVMB, until such time the corporation has been dissolved, is reinstated, or in good standing with the Board.
